

# **Selection Index 20**

## Description

The "Selection Index 20" strategy invests in pure index funds and is implemented so as to ensure that the return and risk on the portfolio match the benchmark as closely as possible. The strategy is reviewed each year based on clearly defined selection criteria, and is approved by the Board of Trustees. You benefit from low product costs and the portfolio can be delivered to your private assets upon withdrawal. The strategic equity content is 20%.



## Methodology

The index funds are selected according to six predefined criteria (benchmark, performance, cost, deliverability, distribution approval and volume). The best product in the peer group is then chosen and weighted according to the strategic asset allocation in the "Selection Index 20" strategy. The dynamic strategy is quantitatively reviewed once a year and adjusted by the Board of Trustees.
